## Focused Infection Control Surveys

- QSO Memo 20-20-All Prioritization of Surveys
- Compliance F880, F884, F885, E0024
- ODH has completed 317 Focused IC Surveys
- 493 are in process
- 138 to be scheduled within the next week or so.
- ODH anticipates completion by end of June, meeting the July 31 deadline outlined in QSO-20-31-ALL

## Policies

- COVID-19 Specific
- Placement
- Emergency Preparedness E-24
- When to notify local health department
- Infection Surveillance (temp every shift)
- Protocol for testing
- Transfer protocol



## Observations

- Hand hygiene practices – ABHR
- Cough etiquette
- Proper use/discarding of PPE
- Cleaning – environment & medical equipment
- Signage at entrances and resident rooms
- Screening
- Effective Transmission-Based Precautions



## Record Review

### Resident Record

- New admit, dialysis, non-COVID resp infection
- Placement - did you do what your policy says
- Dialysis – protocol for leaving the building
- Physician & family notification of changes
- Prompt identification and response



## Interviews

- Staff
  - DON, 2 nurses, 2 STNA's, 3 residents
- Policy/Procedure knowledge
- Surveillance for sign/symptoms
- Notifying local health officials
- Communications about COVID-19 activity in the facility



## Facility Self-Assessment – Focused Survey Tool QSO-20-20-All

Priority areas for self- assessment include all of the following:

- 1. Standard & Transmission-based Precautions;
- 2. Resident care (including resident placement);
- 3. Infection prevention and control standards, policies and procedures;
- 4. Infection surveillance;
- 5. Visitor entry;
- 6. Education, monitoring, and screening of staff;
- 7. Communications on COVID-19 activity and mitigating actions taken;
- 8. Reporting to CDC’s National Healthcare Safety Network;
- 9. Emergency preparedness – staffing emergency

## QSO-20-31-All

COVID-19 Survey Activities, CARES Act Funding, Enhanced Enforcement for Infection Control deficiencies, and Quality Improvement Activities in Nursing Homes

- 1. Previous COVID-19 outbreaks, defined as: 10% or greater; or 20% or greater confirmed plus suspected; or Ten or more deaths reported due to COVID-19.
- 2. NHSN - New COVID-19 suspected and confirmed cases (3 or more), or 1 confirmed resident case in a facility that was previously COVID-free.
- 3. Starting in FY 2021, annual Focused Infection Control surveys of 20 percent of nursing homes based on State discretion or additional data that identifies facility and community risks.

### Ohio's Data Infection Control Citations

Total number of times infection control cited

Cycle 1 =445, Cycle 2 = 403, Cycle 3 = 314

Individual SNF's receiving Infection Control citations

Ohio Cycle 1 = 393, Cycle 2 = 372, Cycle 3 = 287



## QSO-20-31-All

### Additional COVID Activities

CARES Act funds may also be used for State-specific interventions (such as Strike Teams, enhanced surveillance, or monitoring of nursing homes). In addition, in August 2020, State Survey Agency priorities may also be informed by recommendations from the Coronavirus Commission for Safety and Quality in Nursing Homes.

Phase 3 reopening – prioritized surveys: • Abuse or neglect; • Infection control; • Violations of transfer or discharge requirements; • Insufficient staffing or competency; or • Other quality of care issues (e.g., falls, pressure ulcers, etc.).

Directed Plan of Correction (Scope & Severity D, E),  
Discretionary Denial of Payment for New Admissions  
with 45-days to demonstrate compliance with  
Infection Control deficiencies (Scope & Severity F)

CMP up to \$5000 or \$10,000

30-days and CMP up to \$15,000 to \$20,000

Harm & Immediate Jeopardy - additional

- Weekly data through Sunday midnight
- Delay of 11 days
- View your data weekly



## Infection Control Assessment & Response (ICAR)

Ohio has completed 182

Areas assessed include:

- Visitor restriction
- Education, monitoring, and screening of healthcare personnel & residents
- Ensuring availability of PPE and other supplies
- Ensuring adherence to recommended infection prevention and control (IPC) practices
- Communicating with the health department and other healthcare facilities
