QIP Collaborative Results

- The overall financial impact for the collaborative is \$3.58 Million
- On average of those participates that improved their QIP points, they will see an increase of \$240,000
- 72% of participants in the collaborative improved their QIP points
- QIP will remain in future rate settings

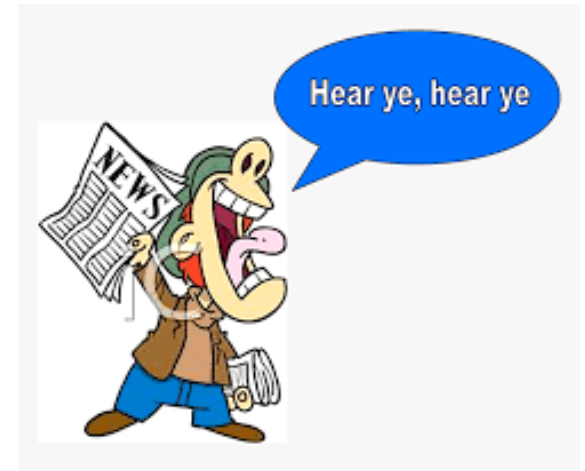
