Federal Eviction Moratorium Announced

Yesterday, the CDC announced an "exceedingly rare" order to temporarily halt evictions for people impacted by COVID-19. Housing providers, including HUD-assisted senior housing, are prohibited from evicting residents under a certain income threshold for non-payment of rent until December 31. Rent payments are still due, and housing providers can still charge late fees. LeadingAge welcomes the new protections and we will work with federal agencies to provide accompanying relief for housing providers. Read more about the order here.
