



Oh, the stories scammers tell . . .

Phony Social Security Administration – "Your Social Security number has been frozen, but we'll help you keep your money 'safe'!"

Health & Human Services/Medicare con – "Call now for your free back brace!"

IRS imposter – "There's a lawsuit against you for unpaid taxes."

Fake government grant offer – "You're eligible for a government grant . . . for a fee."

Bogus police, sheriff, or FBI – "There is a warrant for your arrest for failing to appear in court!"

Contact tracing call? 5 things to know **Contact Tracing** A contact tracer from your state health department might call if you've been exposed to COVID-19. But scammers are pretending to be contact tracers, too. Here's how you can spot the scam. Real contact tracers won't ask you for money. Only scammers insist on payment by gift card, money transfer, or cryptocurrency. **FTC Consumer Alerts:** Contact tracing doesn't require your bank account or credit card number. Never share account information with anybody who contacts you asking for it. COVID-19 contact tracing text message scams Legitimate contact tracers will never ask for your Social Security number. Never give any part of your Social Security number to anyone who contacts you. Help COVID-19 contact tracers, Your immigration status doesn't matter for not scammers contact tracing, so real tracers won't ask. If they do, you can bet it's a scam. Do not click on a link in a text or email.


